Rules: This meet will be governed by the rules of the National Federation of State High School Rules Book--Boys and Girls Competition. Call (816)464-5400 for rule books.

Individual swimmers may enter a maximum of four events, no more than two of which may be individual events.

Each team shall be permitted a maximum of four entries in an individual event and two entries in relay events (of which only one can score).

Relay only swimmers do not have to swim in an individual event to participate in relays, but they must be entered on the master swimmer entry form. They must pay the \$13.50 entry fee required of all swimmers.

All events will be timed finals. Swimmers will swim in pre-seeded heats as designated in the heat sheet.

All relay cards must list the first and last names of all swimmers (including designated alternates). **Coaches will be given relay cards in their coaches' packets available at the coaches' meeting at 7:30 a.m. at the pool on October 30. One coach from each team must attend the meeting.** Relay swimmers will carry their card to the blocks with them. This is a no card meet for all other events.

Swimmers must be in grades 9-12 and represent the high school that they are currently attending. Eligibility rules and regulations of the Idaho High School Activities Association (IHSAA), and Idaho Code 33-203 will be followed as amended by the Idaho High School Swimming Association at the association annual meeting 2008.

All schools must provide two officials for the duration of the meet.

Entries: All Boise and Meridian schools have paid their District fees with the September registration payment. All Unified and other team swimmers must pay \$13.50 per swimmer (including relay only swimmers). **One check per team!** **Please bring check to the meet.** Do not send individual checks. Make checks payable to:

TVHSS (Treasure Valley High School Swimming). Refunds will not be given.

ENTRY DEADLINE: Wednesday, October 27, 2010 -- 6:00 p.m. All teams not competing Tuesday, October 26th are asked to have their entries in by Friday, October 22th.
